About The NCS™

The National Community Survey™ (The NCS™) report is about the “livability” of Oakdale. The phrase “livable community” is used here to evoke a place that is not simply habitable, but that is desirable. It is not only where people do live, but where they want to live.

Great communities are partnerships of the government, private sector, community-based organizations and residents, all geographically connected. The NCS captures residents' opinions considering ten central facets of a community:

- Economy
- Mobility
- Community Design
- Utilities
- Safety
- Natural Environment
- Parks and Recreation
- Health and Wellness
- Education, Arts and Culture
- Inclusivity & Engagement



The Community Livability Report provides the opinions of a representative sample of 496 residents of the City of Oakdale. The margin of error around any reported percentage is 4% for all respondents and the response rate for the 2020 survey was 30%. The full description of methods used to garner these opinions can be found in the *Technical Appendices* provided under separate cover.

Overview of Results

Oakdale residents enjoy a positive quality of life.

Residents' ratings for the livability of Oakdale and the city's quality of life were strong and tended to be similar to the national benchmarks. More than 8 in 10 residents gave excellent or good ratings to the overall quality of life in the City and to Oakdale as a place to live, and similar proportions indicated they planned to remain in Oakdale for the next five years and would recommend living in Oakdale to someone who asked.

Ratings for government performance and public trust are especially strong.

About two-thirds of residents or more gave positive marks to all aspects of Oakdale government performance. Further, ratings for overall confidence in Oakdale government, the value of services for taxes paid, generally acting in the best interest of the community, being honest, and treating all residents fairly were higher than national averages. Residents were also pleased with the overall customer service provided by Oakdale employees and the overall quality of services provided by the City, with about 8 in 10 awarding high scores to each.

Scores for Mobility in Oakdale are exceptional.

Notably, most aspects for Mobility received ratings that were above national averages. Items for which ratings were higher than the benchmarks, with about 8 in 10 residents awarding high marks to each, were traffic flow on major streets, ease of travel by car, ease of walking, ease of public parking, street cleaning, street lighting, snow removal, and sidewalk maintenance.

Additionally, about 7 in 10 residents gave excellent or good ratings to the ease of travel by bicycle and 6 in 10 were pleased with street repair, and both of these evaluations were also higher than those given elsewhere. However, an area of opportunity exists for the City: the proportions of residents who used alternative means of transportation instead of driving alone were lower than those observed in other communities.

Oakdale's affordability and overall design are appreciated by residents.

About three-quarters of residents or more gave positive reviews to the overall design or layout of Oakdale's residential and commercial areas, the overall appearance of the city, and their neighborhoods as places to live. Further, ratings for variety of housing options, availability of affordable quality housing, land use, planning, and zoning, and cost of living, with about 6 in 10 residents or more giving positive scores, were higher than the national benchmarks.

Facets of Livability

Ratings of importance were compared to ratings of quality to help guide City staff and officials with decisions on future resource allocation and strategic planning areas. When competition for limited resources demands that efficiencies or cutbacks be instituted, it is wise not only to know what facets are deemed most important to residents' quality of life, but which among the most important are perceived to be of relatively lower quality in your community. It is these facets of community livability – more important facets perceived as being of lower quality – to which attention needs to be paid first.

In Oakdale, the only facet of livability rated by residents as higher than the median importance rating (74%) and lower than the median quality rating (76%) was the overall quality of the transportation system (auto, bicycle, foot, bus) in Oakdale.




FIGURE 1: QUALITY OF FACETS OF LIVABILITY- SUMMARY




FIGURE 3: QUALITY OF LIFE IN OAKDALE




FIGURE 4: QUALITY OF LIFE IN OAKDALE - SUMMARY




FIGURE 6: GOVERNMENT PERFORMANCE AND SERVICES




FIGURE 7: GOVERNMENT PERFORMANCE AND SERVICES - SUMMARY



What impact, if any, do you think the economy will have on your family income in the next 6 months?




FIGURE 8: ECONOMIC HEALTH




FIGURE 9: ECONOMIC HEALTH - SUMMARY




FIGURE 12: MOBILITY IN OAKDALE




FIGURE 13: USE OF ALTERNATIVE TRANSPORTATION MODES




FIGURE 14: MOBILITY IN OAKDALE - SUMMARY




FIGURE 16: COMMUNITY DESIGN




FIGURE 17: COMMUNITY DESIGN - SUMMARY





FIGURE 19: UTILITES - SUMMARY




FIGURE 20: SAFETY IN OAKDALE




FIGURE 21: SAFETY-RELATED SERVICES - SUMMARY




FIGURE 23: NATURAL ENVIRONMENT




FIGURE 24: NATURAL ENVIRONMENT - SUMMARY




FIGURE 25: PARKS AND RECREATION






FIGURE 27: HEALTH AND WELLNESS




FIGURE 30: EDUCATION, ARTS AND CULTURE




FIGURE 31: EDUCATION, ARTS AND CULTURE - SUMMARY




FIGURE 32: INCLUSIVITY & ENGAGEMENT




FIGURE 33: INCLUSIVITY & ENGAGEMENT - SUMMARY




FIGURE 35: RESIDENTS' PARTICIPATION IN LAST 12 MONTHS- SUMMARY




FIGURE 38: OAKDALE SUMMERFEST ATTENDANCE

Have you or a member of your household attended Oakdale Summerfest in the past three years?




FIGURE 39: IMPORTANCE OF ASPECTS OF OAKDALE SUMMERFEST
