ORDINANCE NO. 932

REZONING OF CERTAIN PROPERTY ON THE WEST SIDE OF TANNERS LAKE FROM R-3
LOW DENSITY HOUSING, R-5 HIGH DENSITY HOUSING, AND C-2 COMMUNITY
COMMERCIAL TO TANNERS LAKE PLANNED UNIT DEVELOPMENT

The City Council of the City of Oakdale ordains:

Section 1. The property described in Exhibit A, located on the west side of Tanners Lake, is rezoned from Low Density Housing (R-3), High Density Housing (R-5), and Community Commercial (C-2) to Tanners Lake Planned Unit Development (TL-PUD).

Section 2. This Ordinance shall take effect and be in full force from and after its adoption and publication, as provided by law.


