

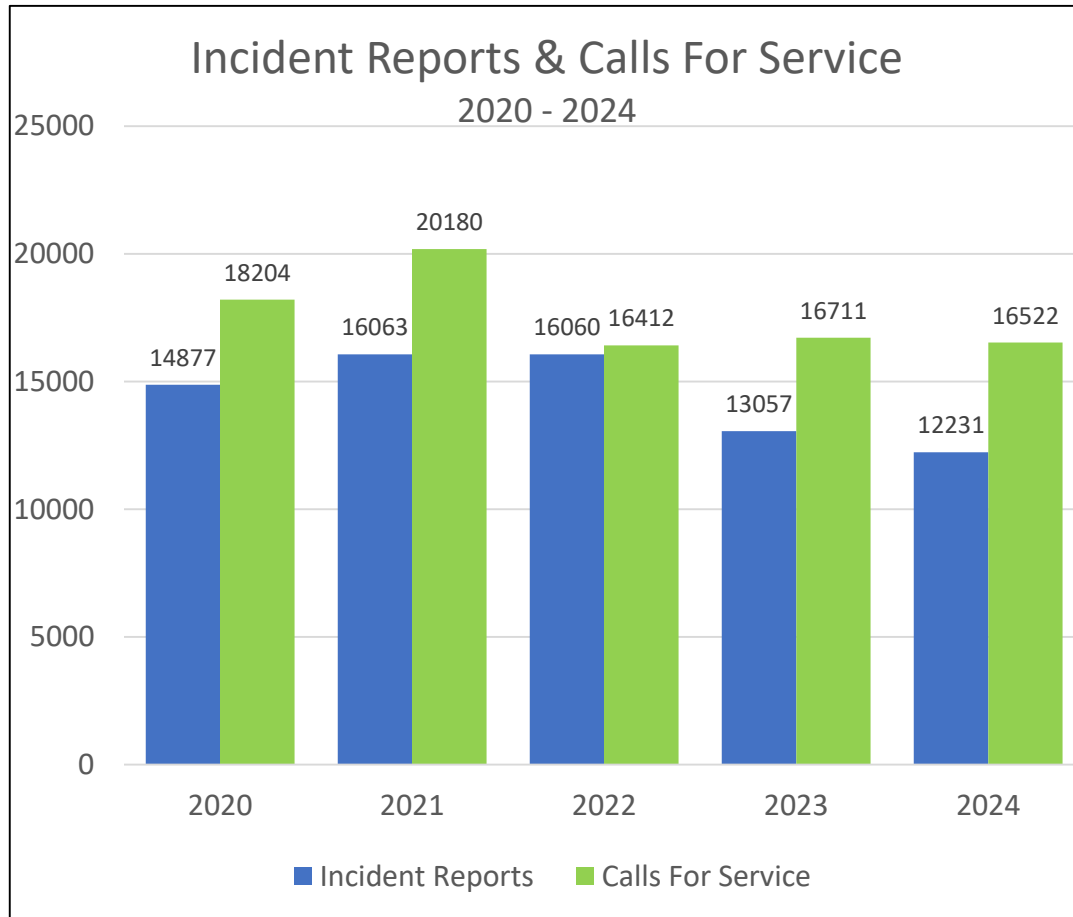

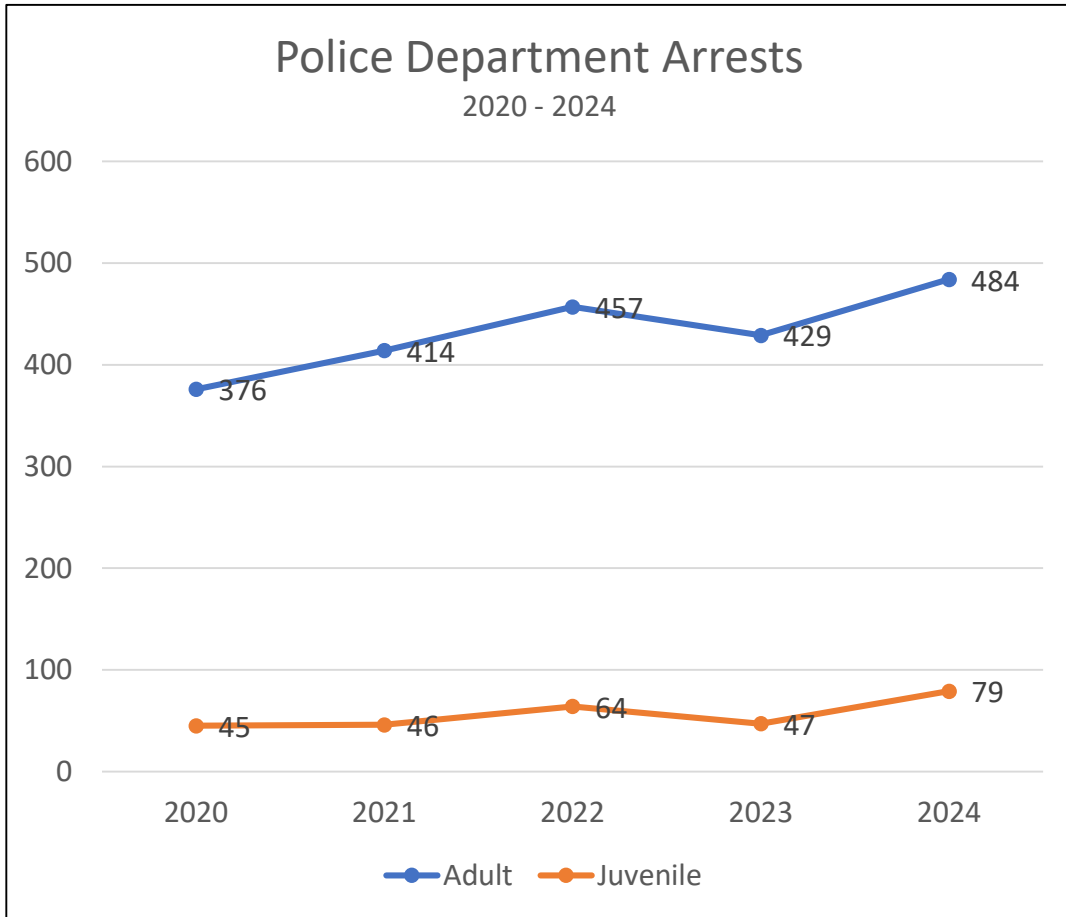


Incident Reports & Calls For Service



- Incident Report means reports completed by staff and coded into database by records staff.
- Calls for service is when a citizen calls 911 or non-emergency dispatcher for a police service. Not all calls for service are documented in an incident report as they are minor, non-criminal matters.

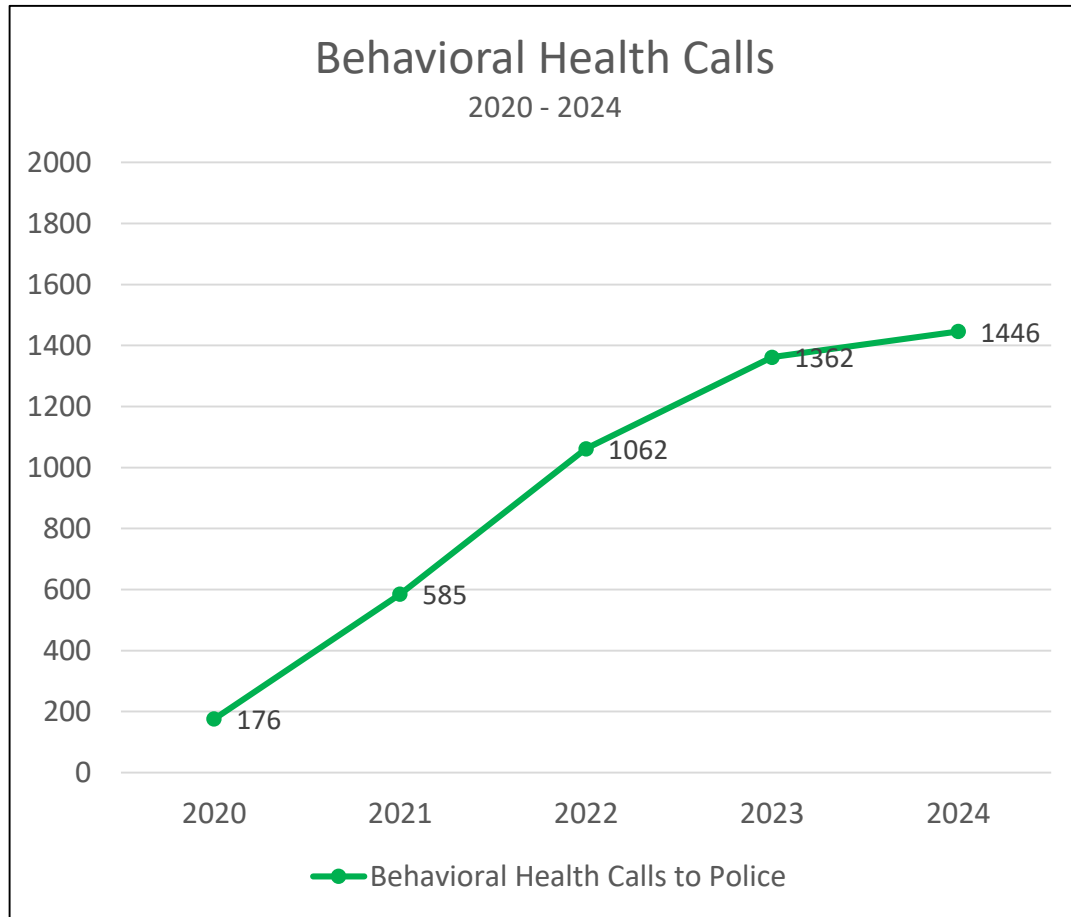
Arrest Information

Behavioral Health

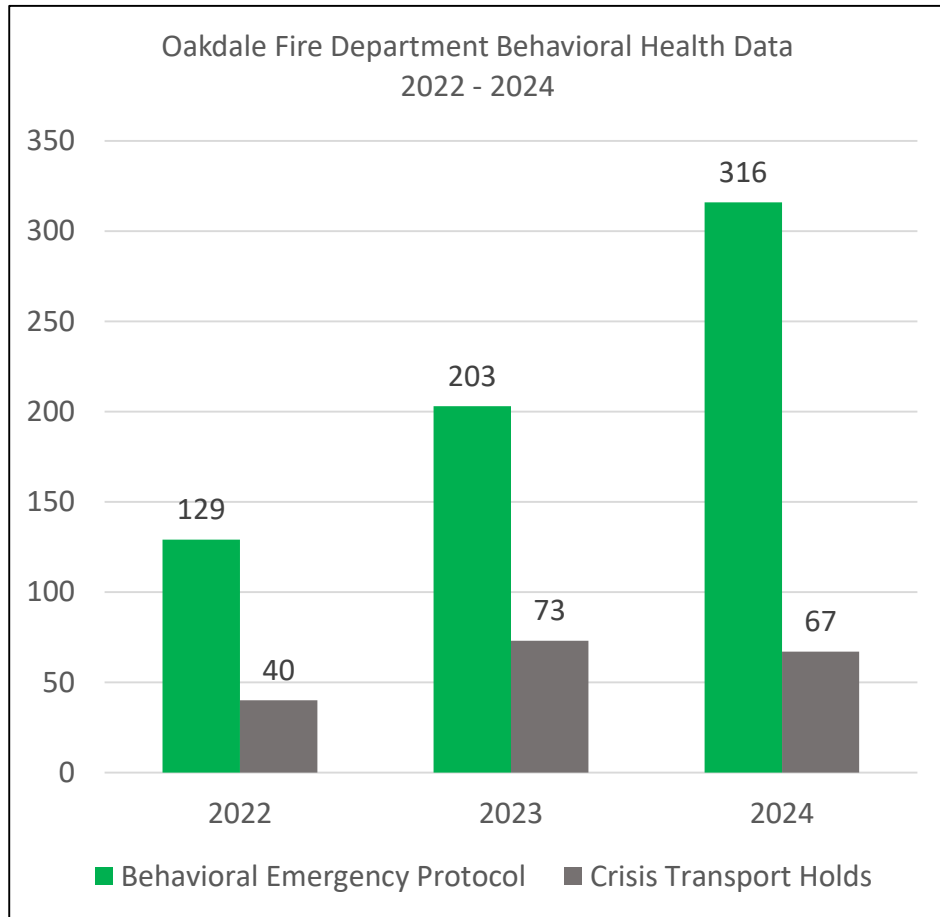


- Behavioral health calls for service is when police respond to a person experiencing a mental health crisis, suicidal ideations, or chemical dependency issues, among other categories.
- While data show sharp increase in behavioral health calls for service, police believe the chart does not accurately represent the number of behavioral health calls; rather, numbers have been increasing over several years and incidents were not documented appropriately.
- Behavioral health calls account for about 12% of police incident reports in 2024. Anecdotally, believed to account for up to 30% of police calls.
- Comparing 2023 to 2024, there was a 6% increase in reported behavioral health calls.

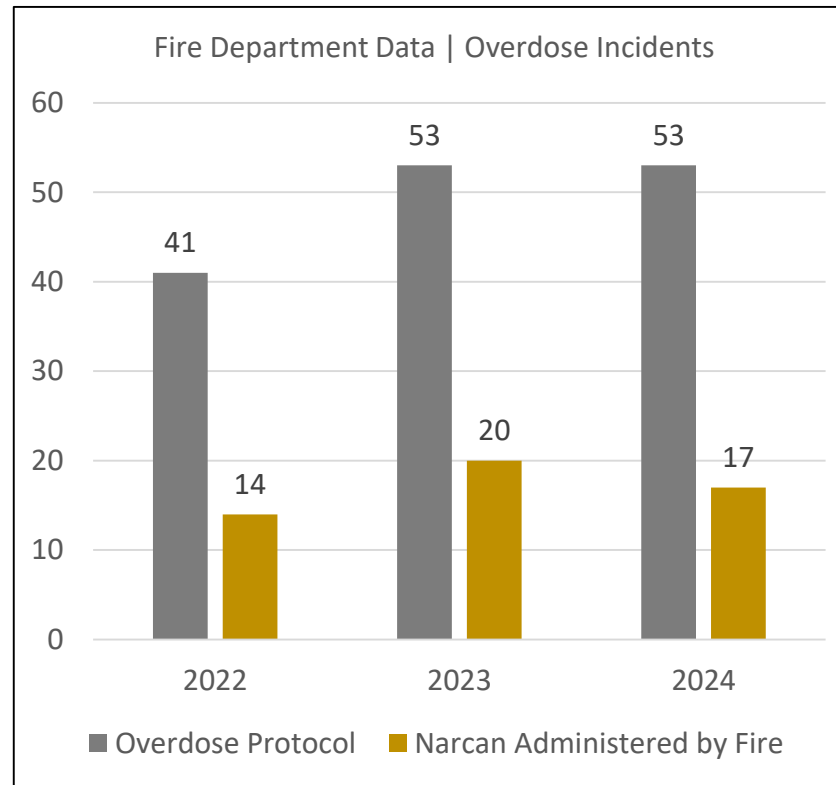
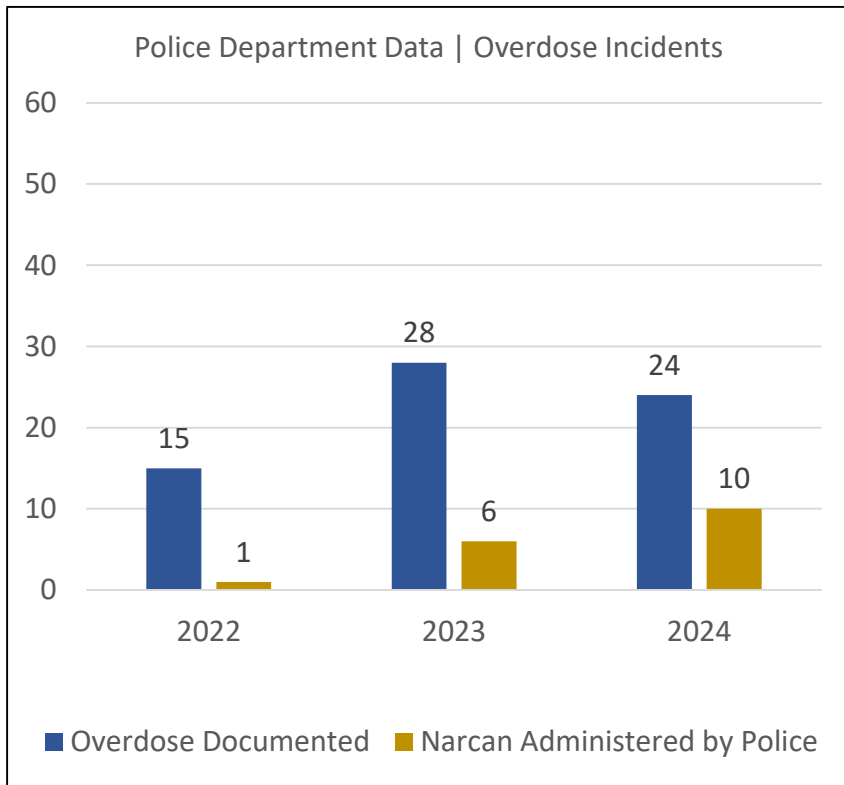
- Will see a slight increase in future years through awareness and better documentation.

Behavioral Health



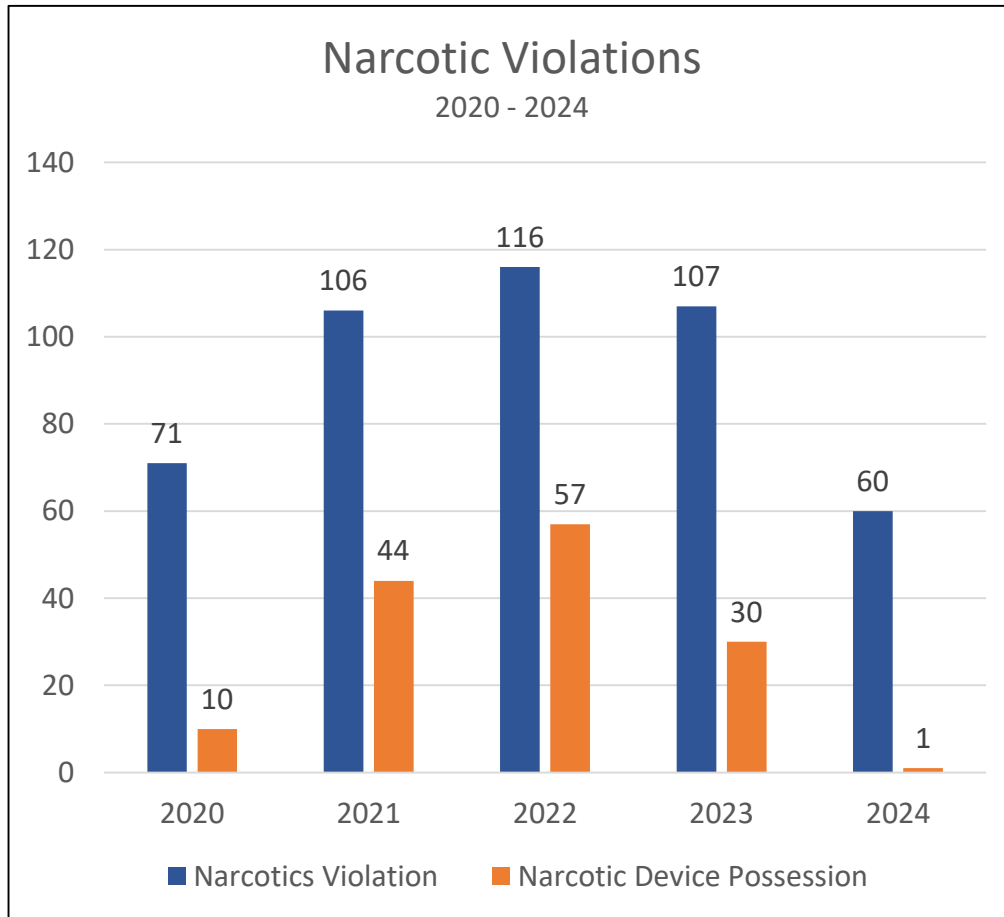
- Behavioral Emergency Protocol is when a person displays symptoms of crisis and Fire staff follow behavioral health protocol as established by the Medical Director.
- Comparing 2023 to 2024:
 - Fire Department documented a 56% increase in behavioral health emergency protocol and a slight decrease crisis transport holds.

Narcotics – Overdose Incidents



- Police Department reports indicate a slight decrease in documented overdoses.
- Police Officers administered Narcan 10 times in 2024, a 67% increase from the previous year.
- Fire Department records show no increase in overdose protocol and slight decrease in administering naloxone (Narcan).

Narcotic Violations

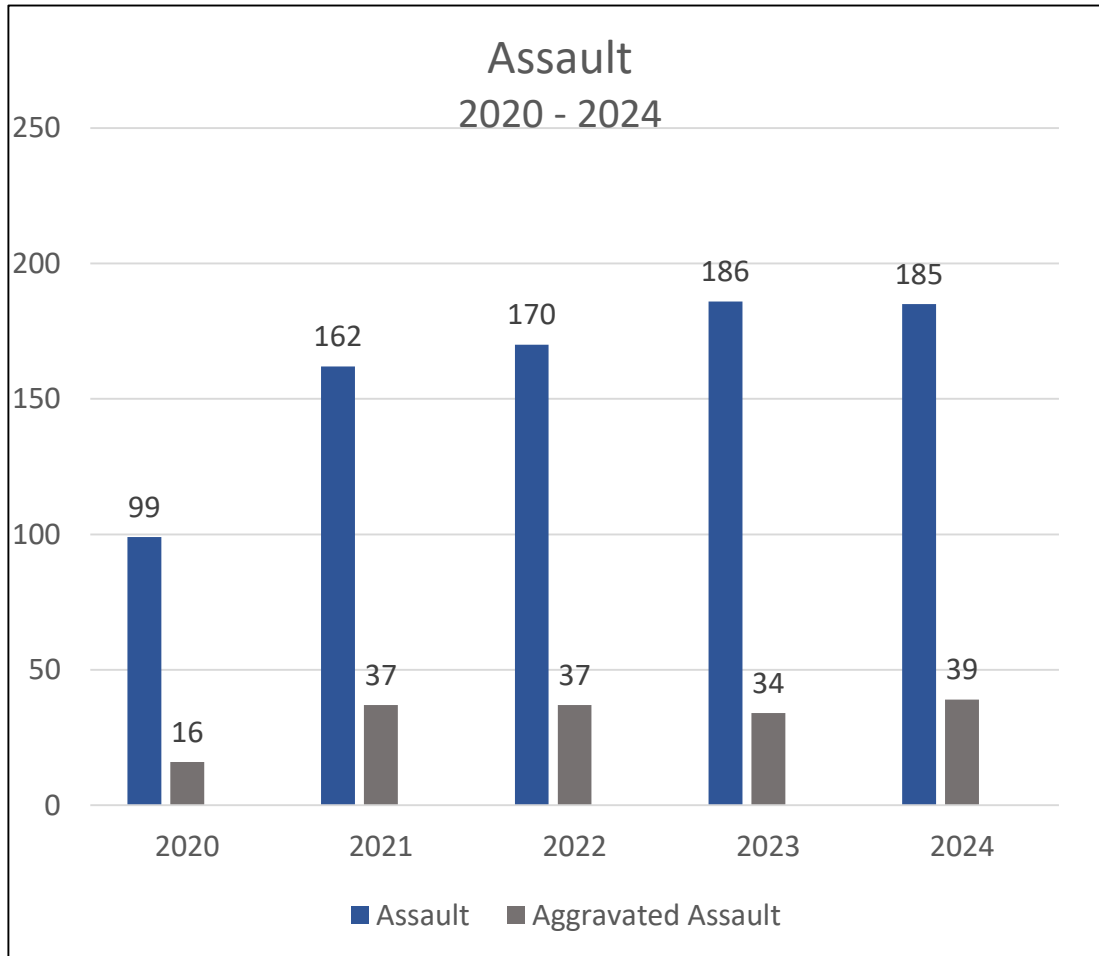


- Narcotics violations include possession or sale of controlled substances (MN Statutes Chapter 152).
- Narcotic device possession includes drug paraphernalia or device used to consume controlled substances.

Assumption on Data:

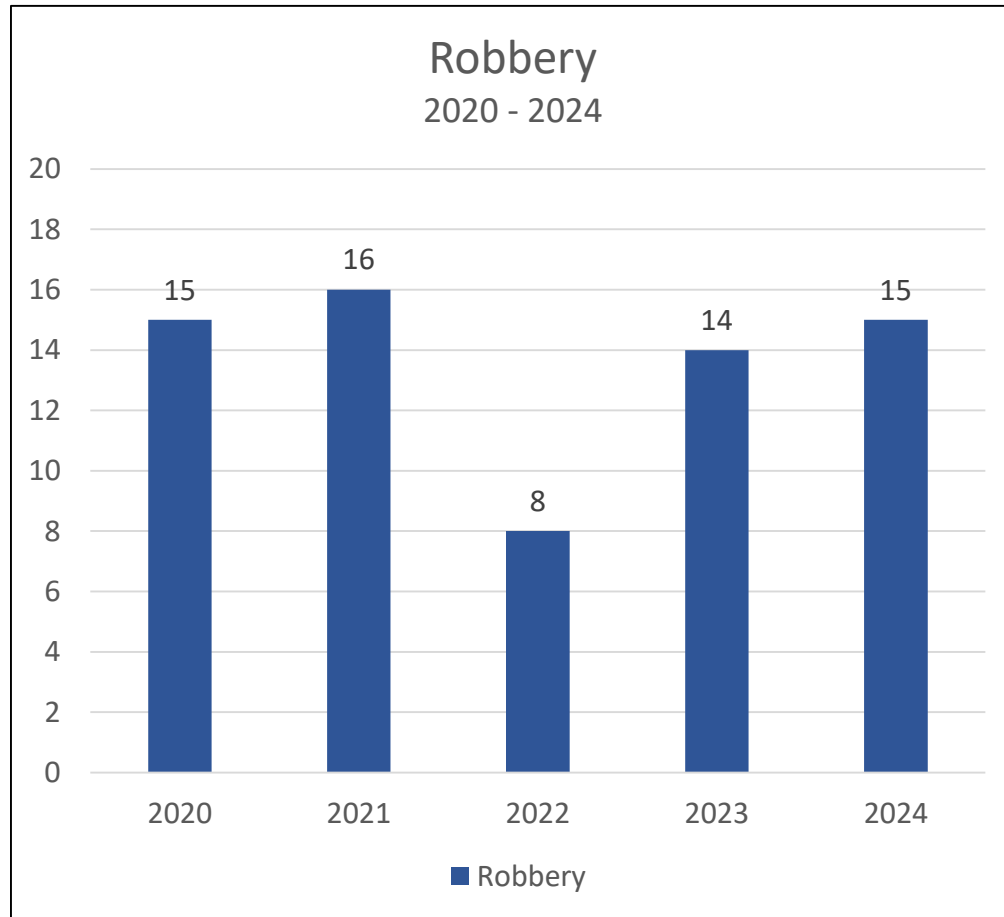
- New cannabis and possession laws are main contributing factor with decrease in narcotic violations and device possession.

Assault



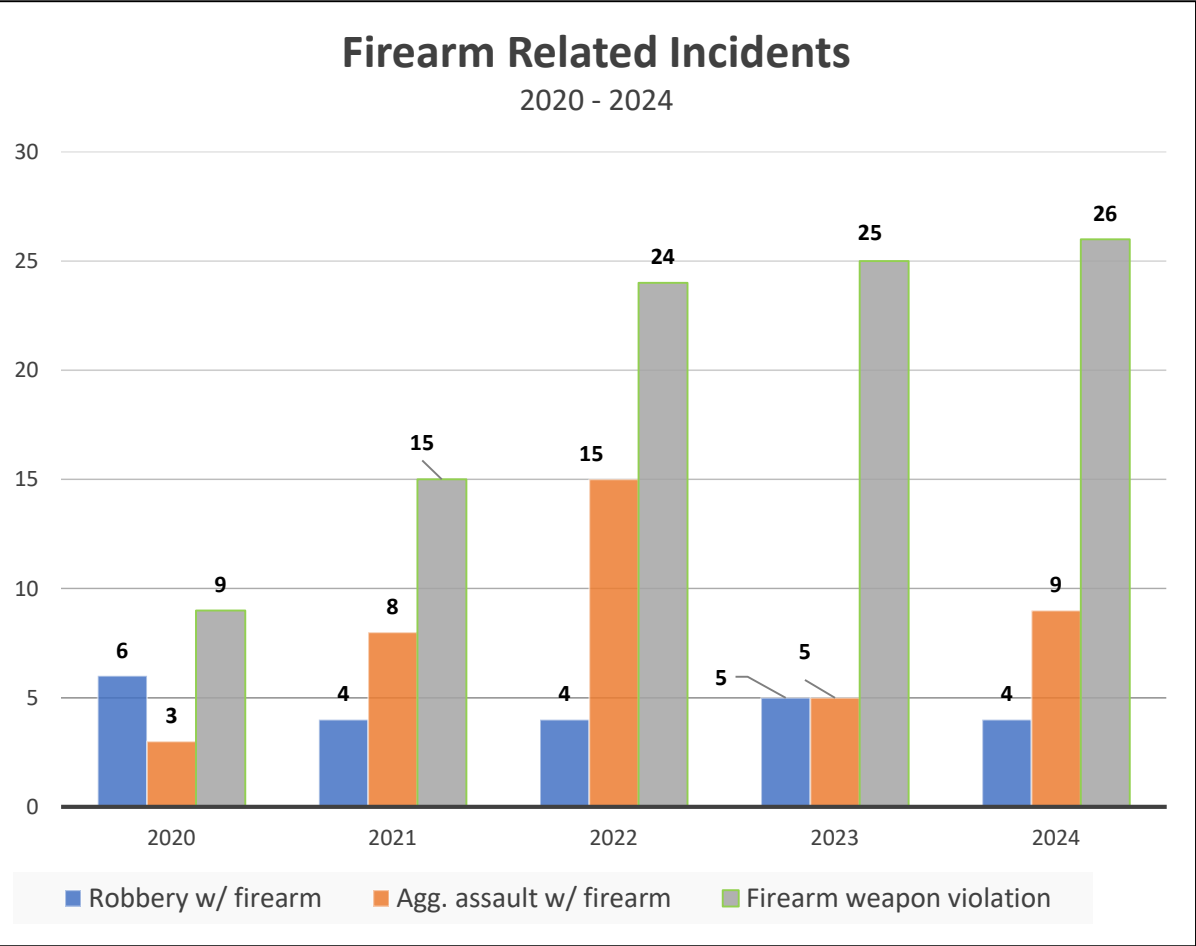
- Assault means an act done with intent to cause fear of immediate bodily harm or death; or, the intentional infliction of or attempt to inflict bodily harm upon another (MN Statutes Chapter 609).
- Aggravated assault is felony assault, or involved a weapon.
- An average of 160 reported assaults annually over the past five years.

Robbery



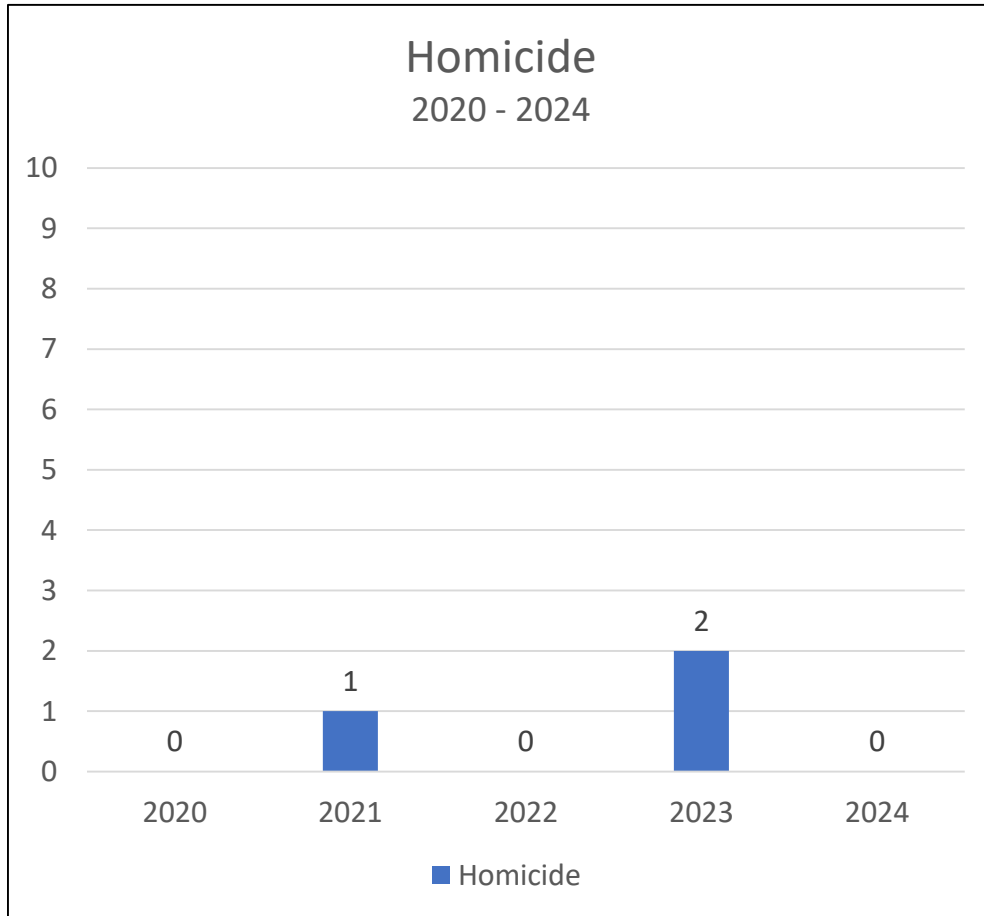
- Robbery is when a person uses or threatens force to take a persons property; or, suspect is armed with a dangerous weapon, by word or act (MN Statutes Chapter 609.24, 609.245).
- An average of 14 robberies annually over the past five years.

Firearm Crimes



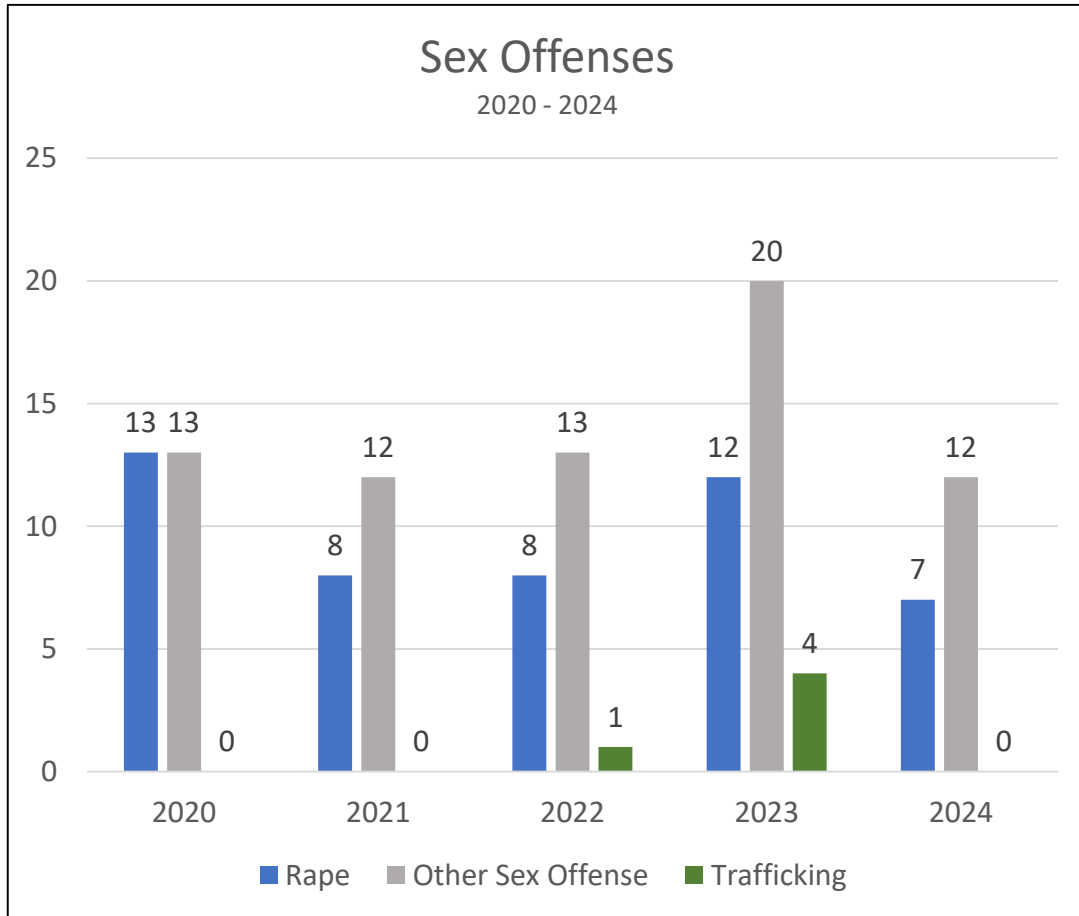

Homicide



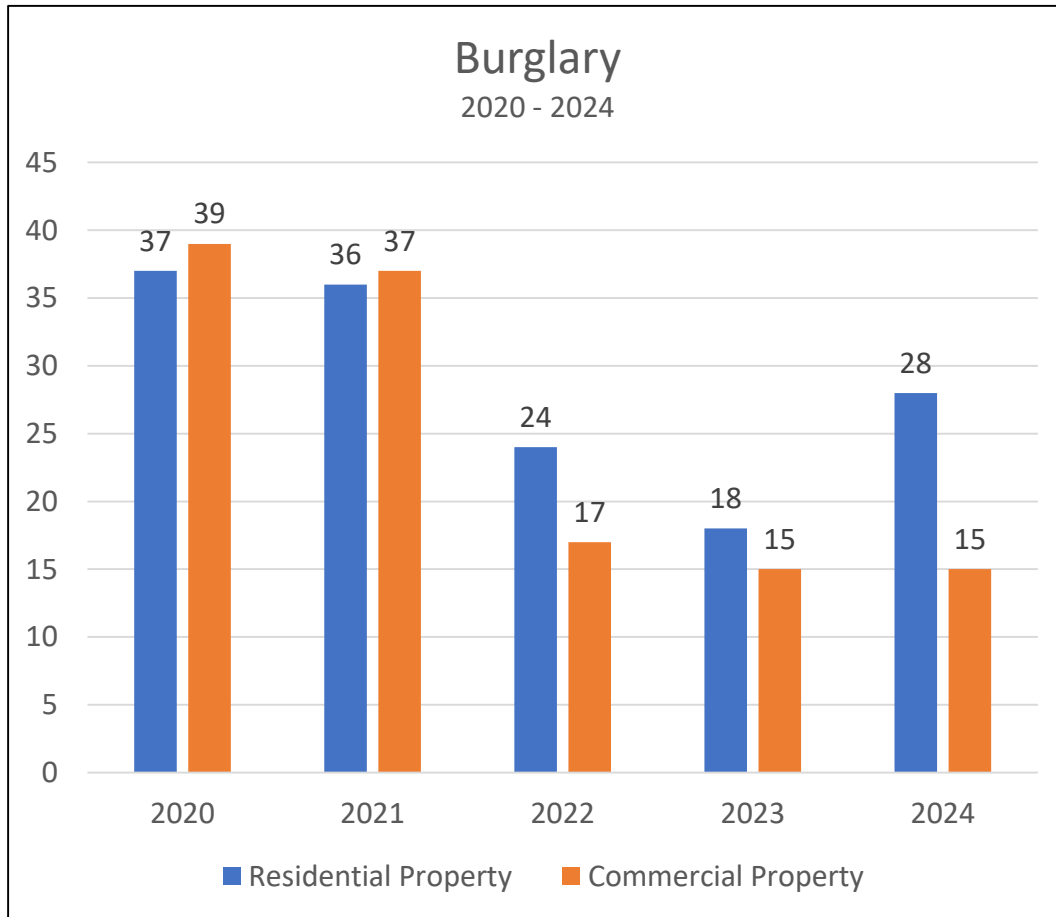
- Homicide is determined by the Medical Examiner. Consists of crimes under MN Statutes 609.18 – 609.215.
 - **2021:** Adult female killed by person that had fled police in a stolen vehicle. Suspect charged with manslaughter and criminal vehicular operation.
 - **2023:** A 94-year-old victim was assaulted by a 75-year-old family member and died several months later as a result of the assault, as determined by Medical Examiner. Case charged as 2nd Degree Murder, case pending.
 - **2023:** Adult male overdosed, toxicology showed lethal amount of fentanyl in system. Adult male charged with 3rd Degree murder, ultimately convicted in December 2024 for felony sale of narcotics.

Sex Related Offenses



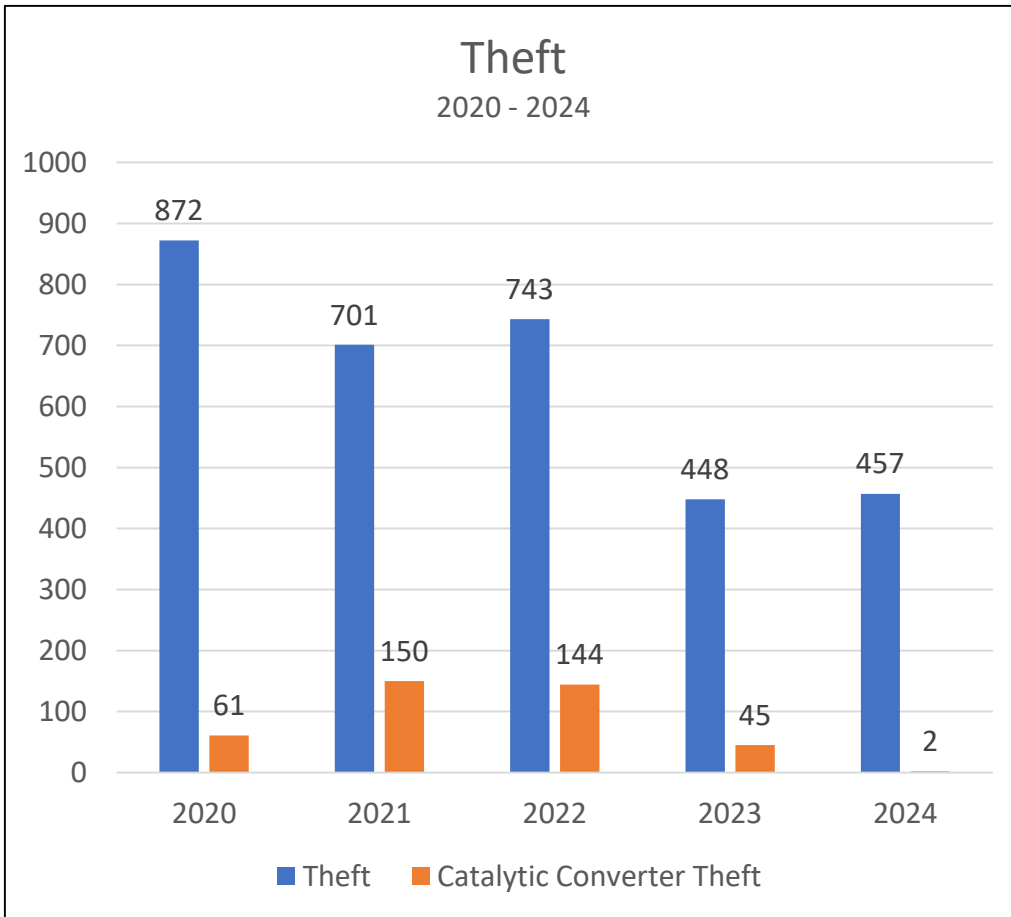
- Rape involves felony criminal sexual conduct (MN Statutes Chapter 609, Sex Crimes).
- Other sex offense include fondling, misdemeanor level offenses, and obscene material such as child pornography.
- Trafficking involves human trafficking for the purpose of sexual exploitation.

Burglary



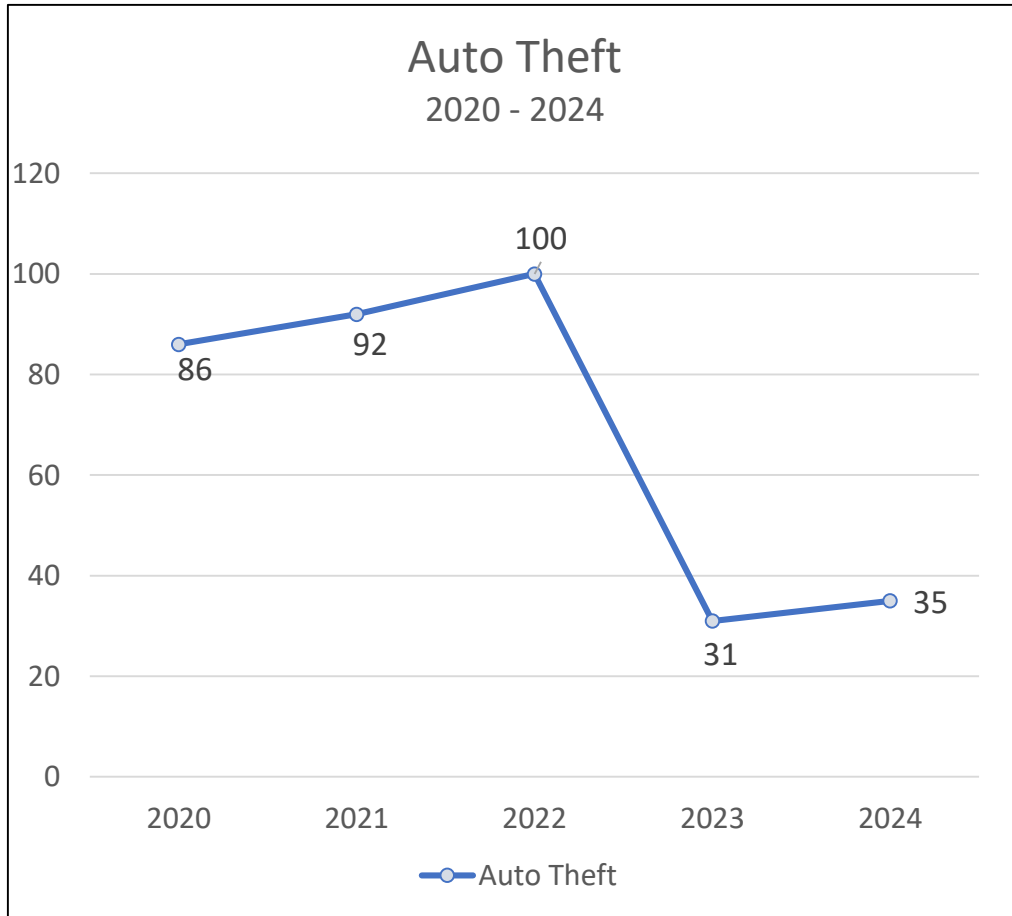
- Burglary is when a person enters a building or dwelling with intent to steal (MN Statute 609.582).
- Comparing 2023 to 2024, there was a 30% increase in reported burglaries.
- Average of 53 reported burglaries annually over the past five years.

Theft



- Theft is when someone permanently deprives another of property (MN Statute 609.52).
- An average of 644 reported thefts annually during the past five years.
- Comparing 2023 to 2024:
 - 2% increase in reported theft.
 - 96% decrease in catalytic converter theft.

Auto Theft



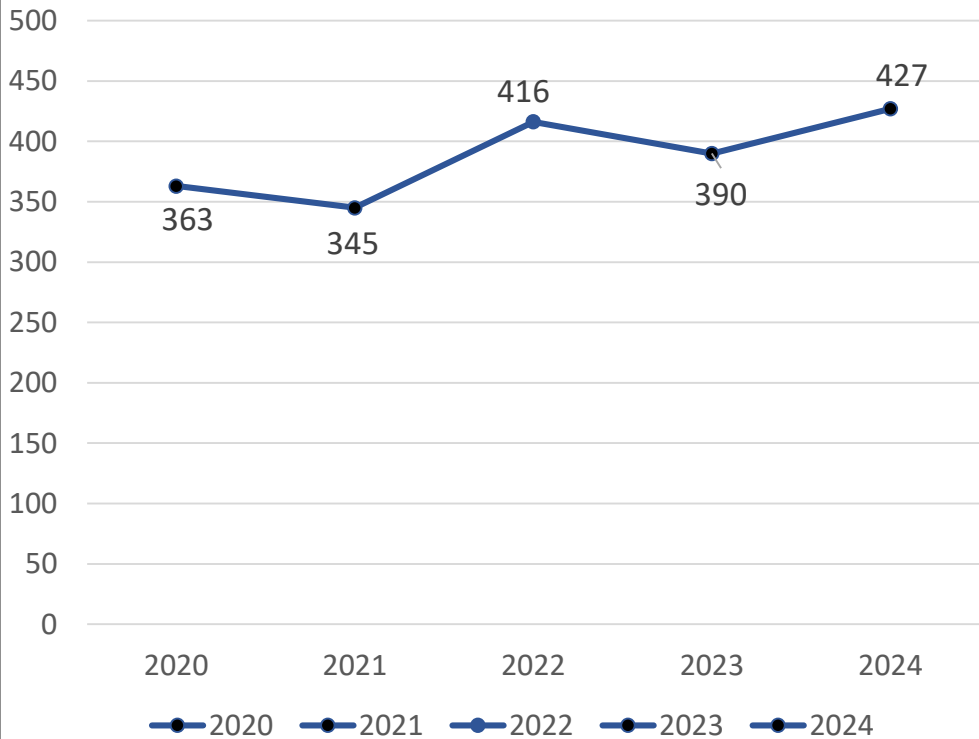
- Data show a steady increase reported auto thefts from 2020 to 2022.
- Experienced a 69% decrease in auto theft from 2022 to 2023.
- An average of 69 reported auto thefts annually over the past five years.

Assumptions on data:

- Small group responsible for auto thefts and some were incarcerated in 2023.
- Ramsey County auto theft investigation unit contributed to decrease in the East Metro.

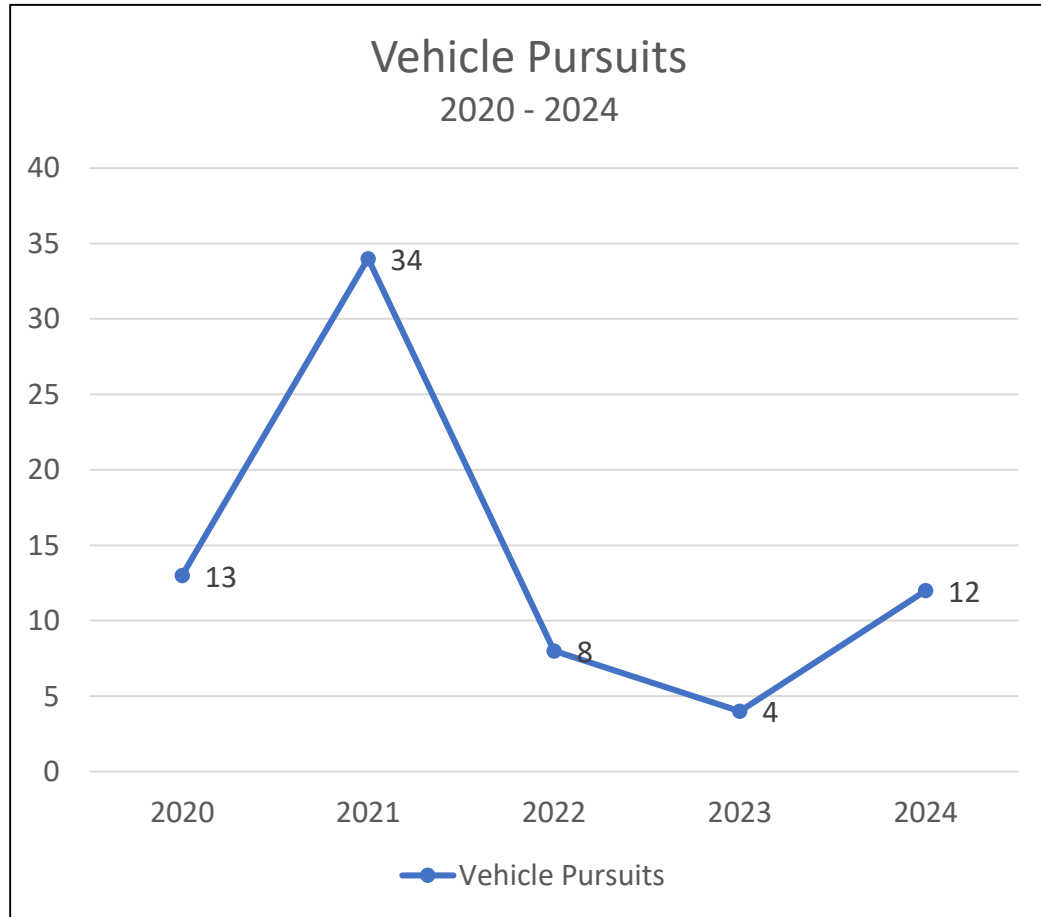

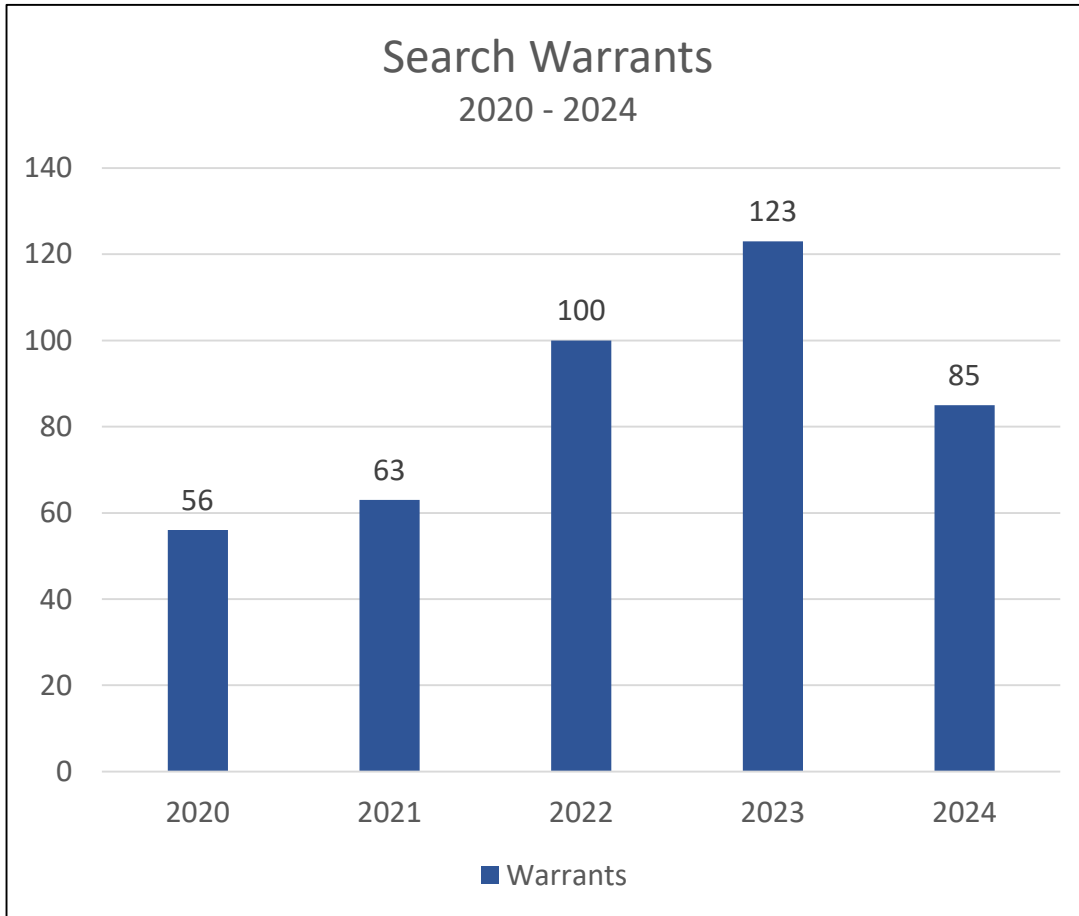

Vehicle Pursuits



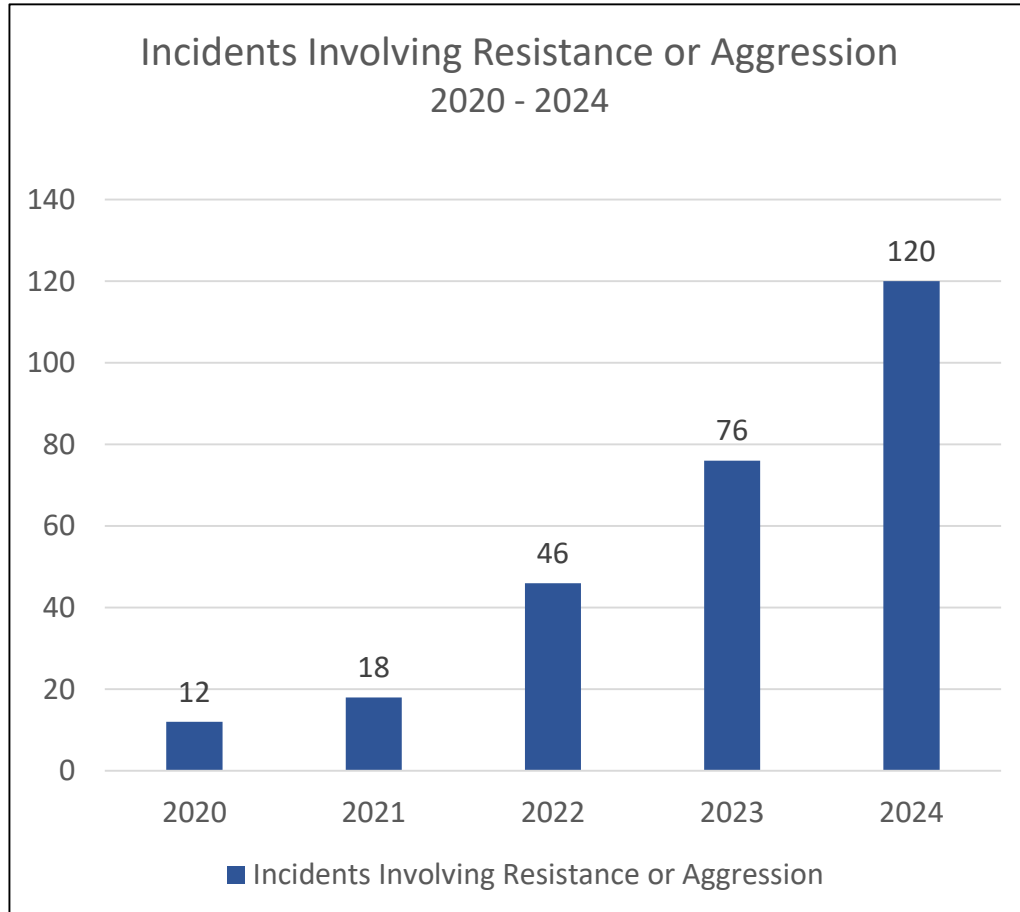
- 2021 was an outlier year.
- Minus the outlier year of 2021, an average of nine pursuits annually.

Search Warrants



- Search Warrant means an affidavit articulating probable cause to search a person and or property signed by a Judge authorizing the search of said person or property.
- There were no “no-knock” warrants conducted by the Oakdale Police Department 2020 - 2024.

Police Use of Force

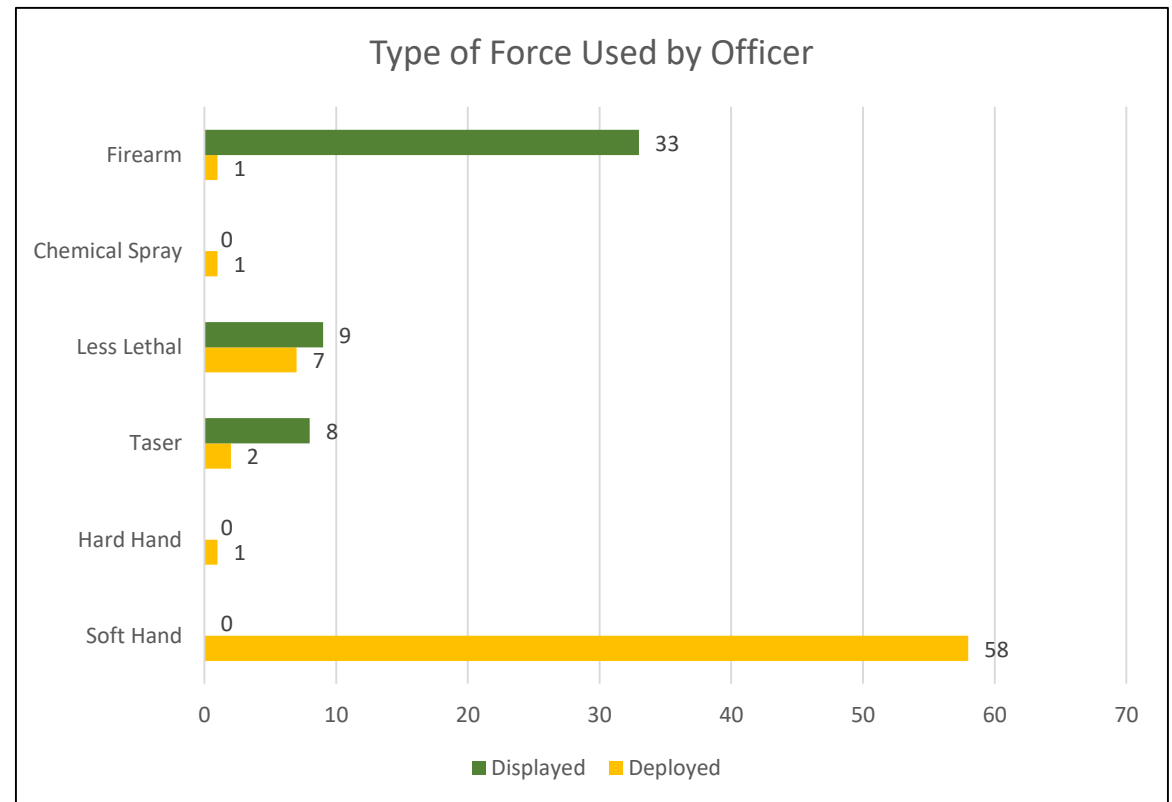
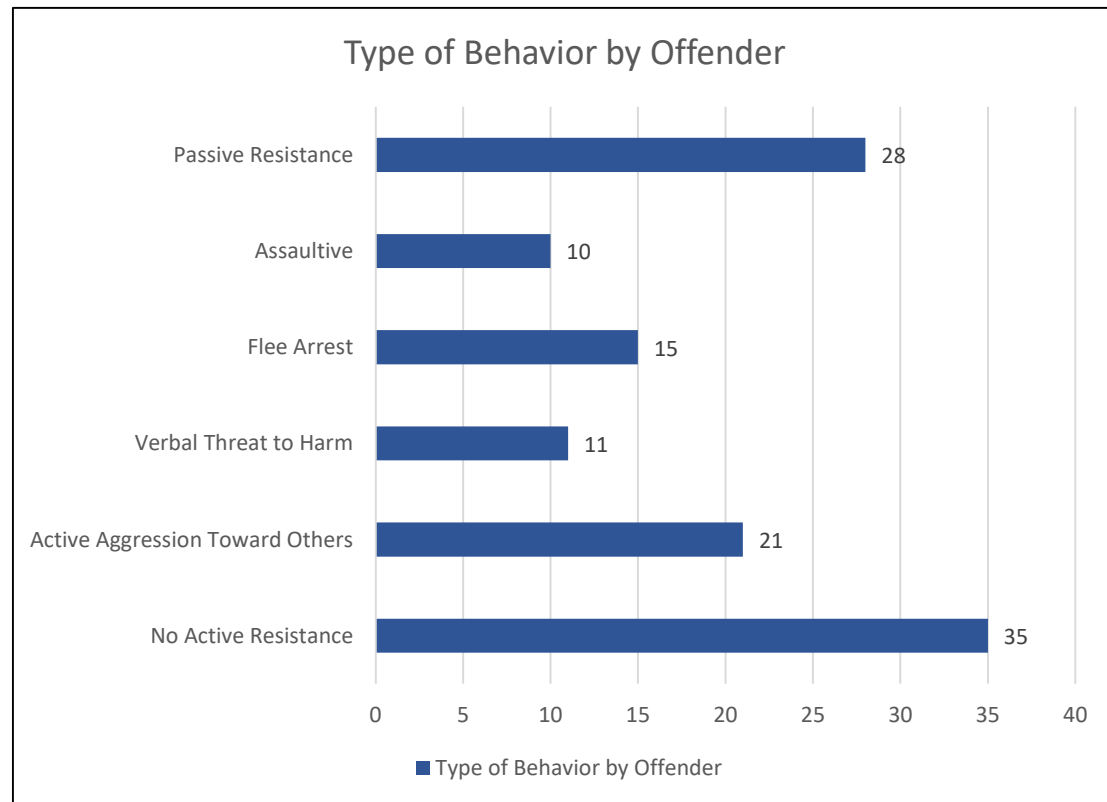


- Response to resistance or aggression is anytime an officer uses physical means or weapons systems to control another person. Any controlling methods beyond handcuffing require a report, including pointing a weapon at a person.
- There was a 58 % increase of reports involving resistance or aggression from 2023 to 2024.

Assumption on Data:

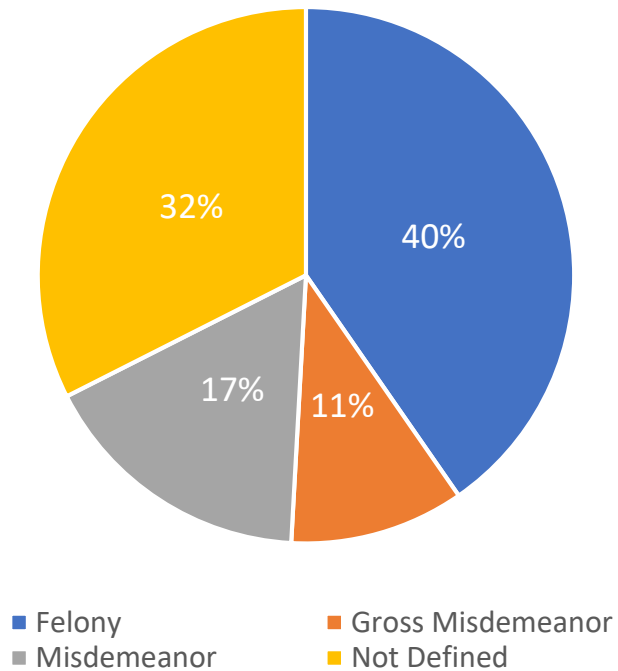
- Increase due in part to more arrests and incidents requiring use of force.
- A new digital form and process for documenting started in late 2020 with guidelines on when to complete reports and allowed a much easier process for accurately reporting.
- The change in process evolved over recent years has become standard practice.

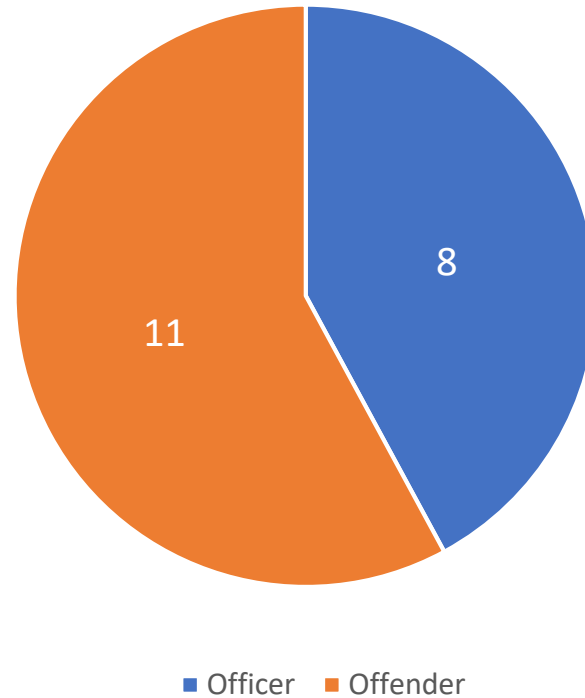


Police Use of Force | 2024

Level of Crime Committed by Offender

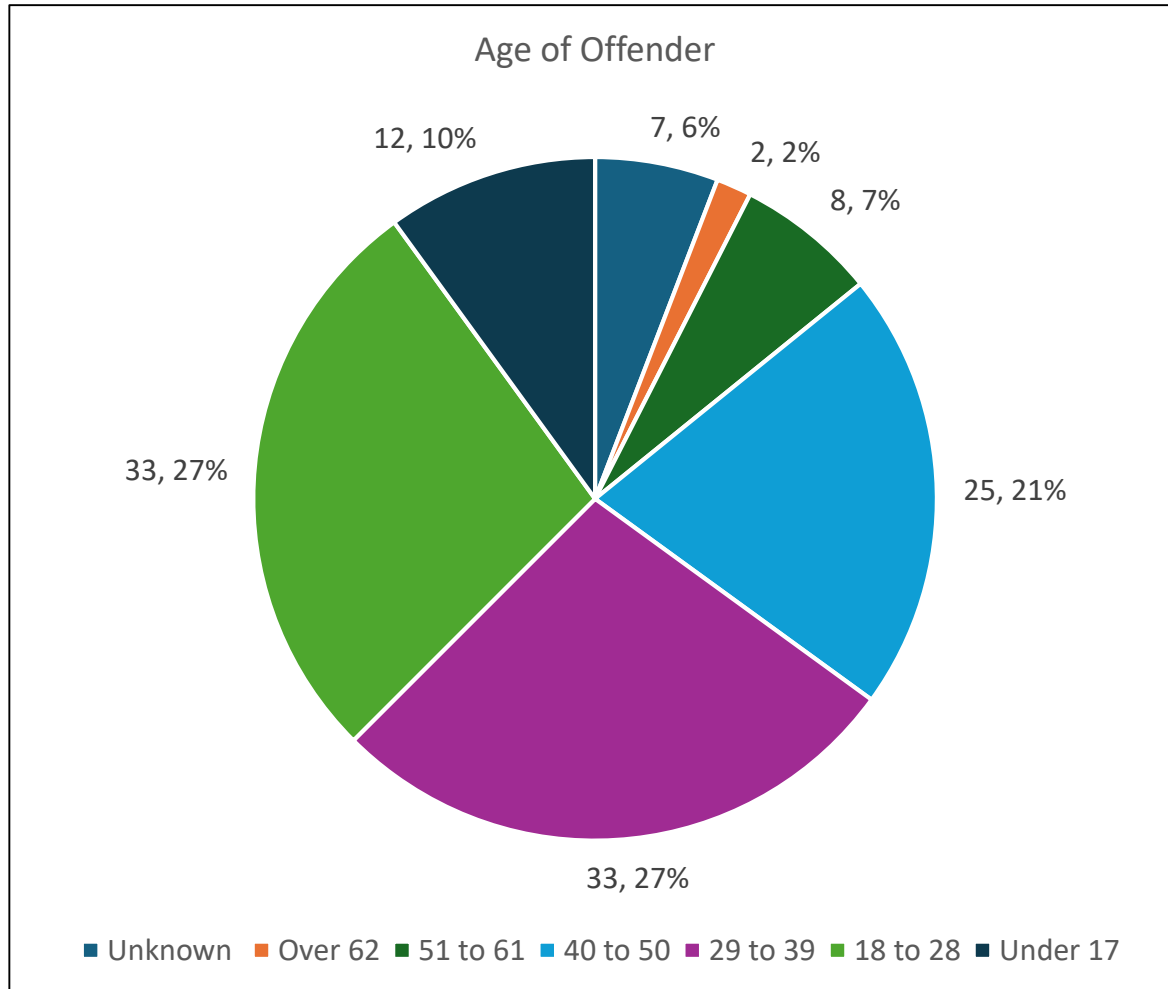


Reported Minor Injury

- No Serious Injuries reported.

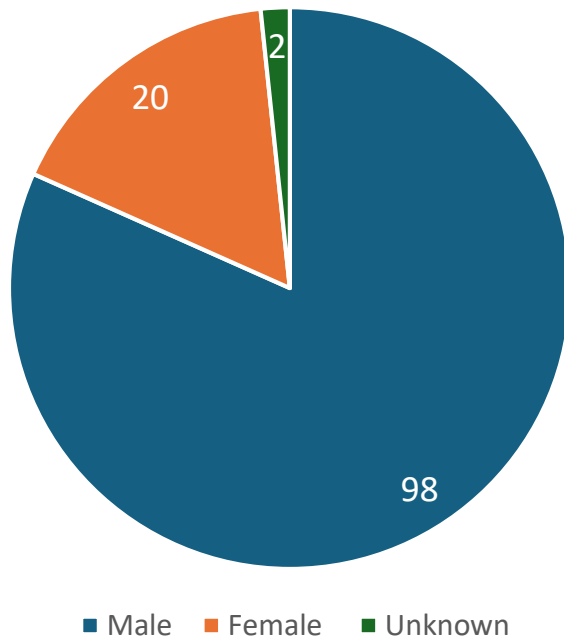

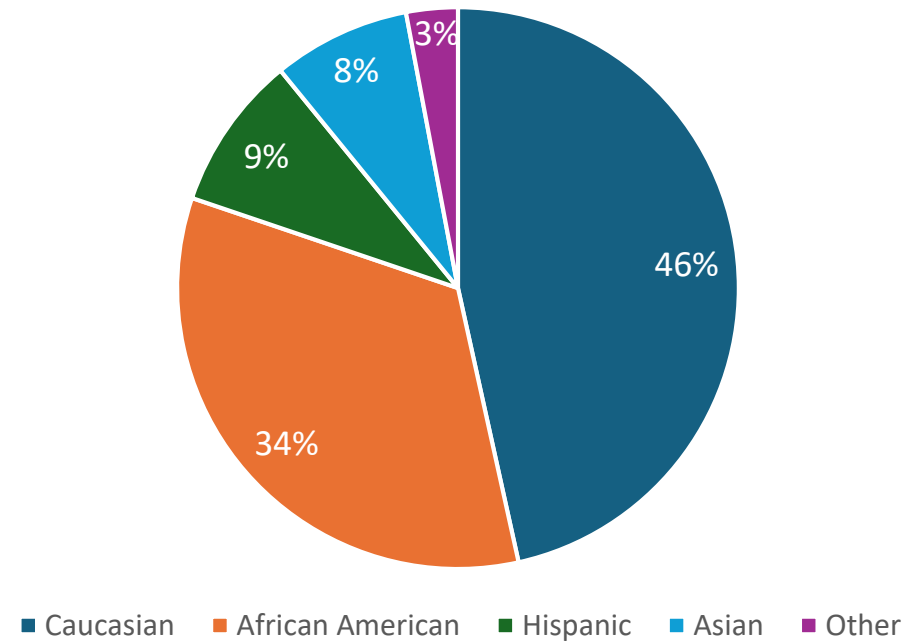
- 54% of incidents involved persons between the ages of 18 and 39.

Sex of Offender

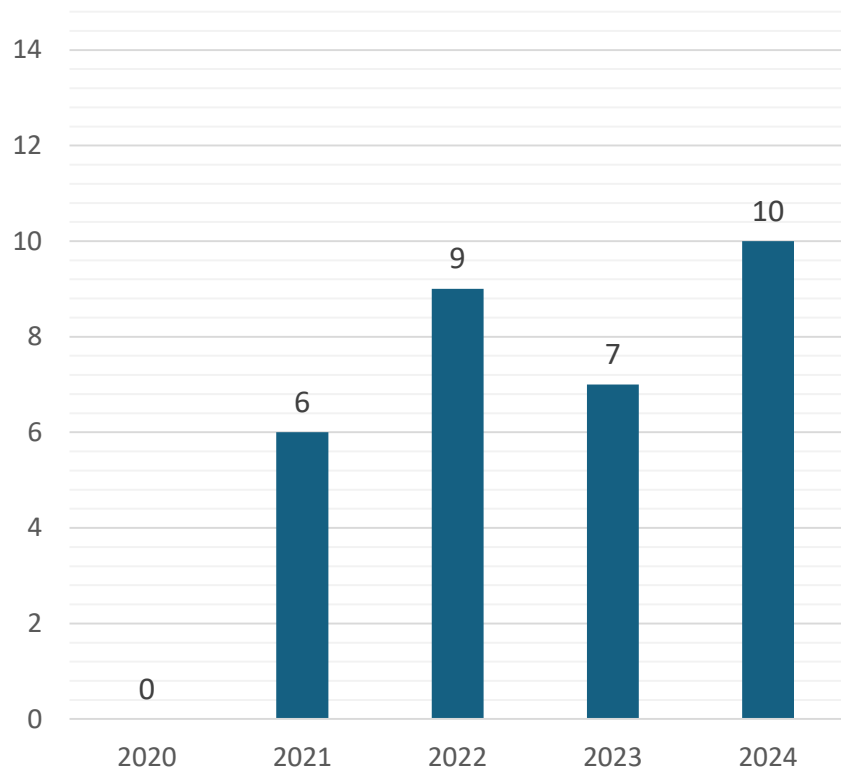


Race of Offender

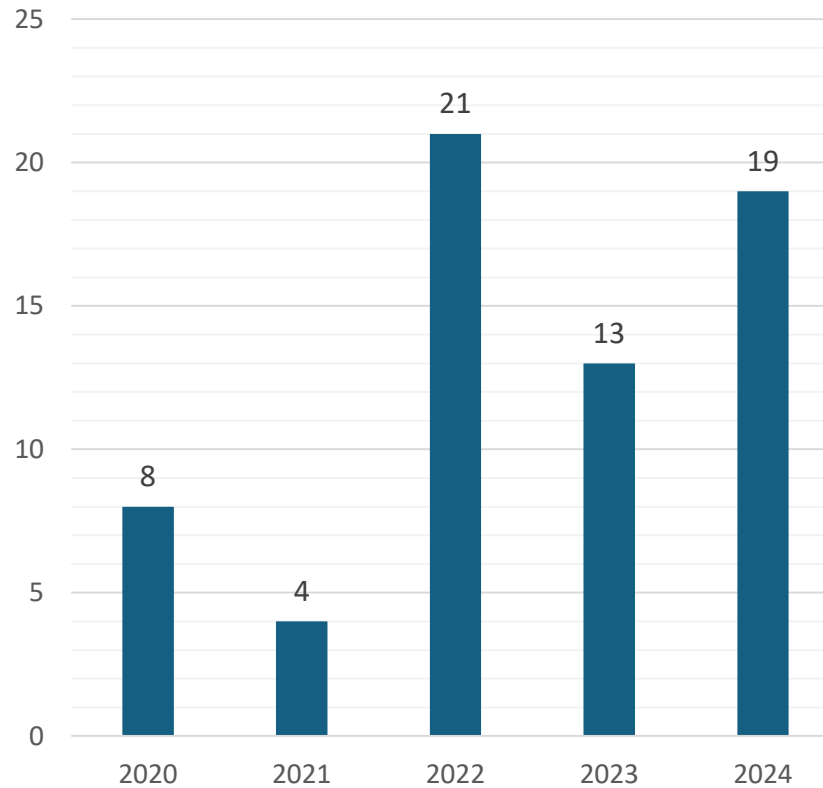


Assault on Police Officer & Offender Obstructing Legal Process with Force
